**The College is further asked to seek approval from Bar Council of India for the session 2026-27 in LLB (Hons)-3 Year program and BALLB (Hons)-5 Year program with an intake of 120 seats in each program.**

The above extension/continuation in provisional affiliation is granted with the condition that the college will appoint a permanent Principal and other teaching and non-teaching staff and also submit Fire Safety Certificate as per Government norms and must address the deficiencies as pointed out by the Inspection Committee in its report dated 15.02.2025 **in next three months** and compliance with the BCI norms to maintain compliance with University and regulatory requirements at the earliest.
